5) Footpath in Pouy Street:

Burroughes with the details.

6) Verge Trimming:

It was noted that the verges badly need trimming especially in some places to look at asking a person to cut back the verges. The Clerk said that this was normally the remit of the Suffolk Highways and he would check the power for the Parish Council to trim verges.

7) <u>Clerk's Report, Correspondence and Donations:</u>

The Clerk said that he received a letter regarding the Sizewell C Consultation and reported that he had heard nothing from the insurers.
